## WHO WE ARE

The Poweshiek Housing Assistance Fund was established in 2020 by the Claude W. and Dolly Ahrens Foundation after a Housing Coalition was formed in 2019 over growing concerns of homelessness in Poweshiek County.

## PROGRAM CRITERIA

- 1 Assistance for rental deposits or back rent
- 2 Assistance for utility bills related to obtaining housing
- 3 Assistance for mitigating damage to a rental unit
- 4 Assistance to obtain legal documents in order to apply for other housing funding assistance in the county
- 5 Assistance for other extenuating circumstances related to obtaining housing

## HOUSING NEEDS

A county-wide survey of landlords and others involved in housing revealed:

- An estimated 900 individuals need affordable housing (\$535 per month or lower).
- Only 40 affordable housing units currently exist.
- The annual unmet housing need is about \$100,000.

As a result of this need the 25-member housing coalition formed three task forces to:

- 1 Map available resources
- 2 Address transportation issues
- 3 Fundraise for anticipated needs



## FUNDING GUIDELINES

- Funding will be reviewed on a case-by-case basis.
- Funding will be paid directly to landlords or public entities such as utility companies.
- Annual cap of \$500 of funding per individual.
- All individuals that receive assistance remain anonymous.
- Applications/reimbursement forms must be completed by the Grinnell Housing Authority on behalf of individuals. A "Client #" must be assigned to each individual in order to maintain anonymity.
- Grinnell Housing Authority's rent subsidy program helps qualified families and individuals pay rent. This income based program's purpose is to provide decent, safe and sanitary housing. Please contact to refer an individual in need:
